Child Protection Policy and Procedures for people working within the Parish

To ensure adequate care and respect for the dignity of each child under our care in St. Brendan's Parish we recommend:

- All adults engaged with activities involving children in our parish will be vetted and sign approval appropriate forms.
- In future a parent or guardian will sign consent forms for their child taking part in any church activities. A consent form from both parents and/care will be sought.
- There will be adequate supervision (male and female) for such church activities at all times.
- There will be all necessary precautions taken to ensure that the recommended adult/child ratio will be adhered to whilst children are engaged in Church activities.
- A child will not travel alone in cars etc. with any one adult.
- Proper procedure will be adhered to, to ensure proper records will be kept on file of all activities and participants, times, and supervisors on duty for all future events.
- Incident report sheets will be filed where warranted.
- Mobile phone numbers of parents /guardians will be expected to be available to the supervising persons at all times.
- Supervisor's mobiles will also be made available to parents for such activities.
- Use of camera phones will not be permitted in church based activities.
- Permission for photography will be sought and records of same kept where this permission is granted.
- Use of Computers or Videos will also be disallowed unless express permission is sought on the relevant forms.
- St .Brendan's Parish has designated persons accountable to, and trained for the Dublin Arch Diocese in relation to Child protection procedures and will refer any concerns raised promptly with appropriate civil and Diocesan authorities.
- Clear procedures will be followed when taking young people away on day trips or retreats, pilgrimages etc.
- A form will be available for such outings and medical information including name of family doctor or clinic will be necessary before embarking on any such outing.
- Recommendations or Omissions to this statement will be welcomed.
